**VII. COMMISSIONERS REPORTS**

Binnie - Parks and Recreation, Streets

**TPW:** PG&E will be replacing the metal plate covering the junction box on the downhill lane of Edwards Street. The Humboldt County Department of Public Works has offered to chip-seal the last section of Scenic Drive if the City pays for the material. The project will cost approximately \$2000-3000. A proposal will be brought to the Council at a future meeting. Suggested that the City accept their offer. The utility pole at the corner of Scenic and Main has been removed and the utilities undergrounded. The project took almost 9 years to complete.

**Trails:** The foot of the Axel Lindgren Memorial Trail has been repaired by TPW.

Bhardwaj – Health & Human Services, Planning

**Health:** Announced the upcoming village keeper list of events.

**Planning:** The March Planning Commission Meeting was cancelled. The Commissioners were asked to attend the Integrated Coastal Watershed Management Planning meeting instead. The BLM Kiosk project proposal for the harbor was withdrawn due to an appeal filed in opposition. The PC will hear the first view restoration permit application filed by residents of Underwood Street against the property owned by the Morrison Family. General Plan update workshops are being held regularly and the public is encouraged to attend.
