MINUTES OF THE REGULAR QUARTERLY MEETING OF THE TRINIDAD TRAILS COMMITTEE TUESDAY, APRIL 18, 2023 VIA ZOOM

I. CALL TO ORDER/ROLL CALL (5:00 pm)

II. APPROVAL OF AGENDA

By consensus the agenda was accepted as submitted.

III. APPROVAL OF MINUTES

Approval of minutes was postponed due to lack of a quorum.

IV. ITEMS FROM THE FLOOR

V. STAFF/COUNCIL REPORTS

West reported that Cheryl and Anita Thompson are no longer members of the Trails Committee.

VI. COMMITTEE MEMBER REPORTS

None.

VII. DISCUSSION/ACTION ITEMS

1. <u>Trail signage - discussion/ decision on trail post replacements and whether or not to add trail</u> <u>names and/or safety information.</u>

West informed the committee that three or four posts have been replaced. He would like to work with the State Parks. He asked for post and sign design ideas.

There was a discussion about the number of committee members.

 Trinidad area management team - report out on any recent meeting outcomes or direction. Discussion about repairing and opening the Parker Creek and Axel Lindgren Memorial Trails. Naffah explained that the goal is to open the Parker Creek Trail and Old Home Beach by Memorial Day weekend. The Axel Lindgren Memorial Trail (ALMT) will remain closed with additional fencing and signage directing people to Parker Creek Trail. Logs, driftwood and debris will be removed from the base of the trail.

Tristan Cole asked about the Trinidad Rancheria's specific concerns about the trails. Naffah stated that the lower part of the ALMT is in bad shape and the Rancheria would like to reroute the trail westward. He also explained that it cuts through the 12.5 acres of study area. He also noted excessive erosion.

Anita Thompson asked about the progress that has been made on the trails since the February 10th closure. Naffah explained that City Planner Trever Parker has been working on the Coastal Development Permit (CDP) and Coastal Commission approval. Nothing physical has been done yet. Thompson noted that trails near the ocean will always suffer from erosion and that safety will always be an issue.

Hopkins asked for clarity regarding the City's liability regarding trails. Naffah explained that usage of trails is "at own risk."

Needham asked why the Tsurai Management Team meetings are closed. Naffah explained that the meetings are closed when they discuss cultural resources. Needham voiced his frustration and noted the lack of repairs over the past 17 years to the ALMT. He also exclaimed that the Parker Creek Trail should not be closed.

Zoe Ziegler stressed the importance of open and early communication when trails are closed.

Anita Thompson noted that in addition to the ALMT and the Parker Creek Trail the Van Wycke Trail is closed and the Galindo Trail is scheduled to be closed.

3. <u>Trail maps - continued discussion on short term and long-term approaches to trail maps (to include a few sample maps)</u>

West provided samples of online trail maps. Zoe Ziegler shared the Land Trust meeting link. Hopkins suggested reaching out to the Trinidad Rancheria and Yurok Tribe for "native names" of locations.

4. <u>Bench program - survey of existing benches will be presented with recommendations for plaque updates and bench repair.</u>

West discussed the bench inventory and policy. The new bench policy offers plaques for \$1,000 for ten (10) years. He will provide a PowerPoint at the next meeting.

5. <u>Update- Steps to Trinidad Head</u>

There was a discussion about the steps to Trinidad Head. Naffah explained that he spoke with the California Conservation Corp. about restoring the steps. He provided a scenario in which 15 people worked for one week at a cost of \$15,600.

MINUTES OF THE REGULAR QUARTERLY MEETING OF THE TRINIDAD TRAILS COMMITTEE TUESDAY, OCTOBER 17, 2023 VIA ZOOM

- I. CALL TO ORDER/ROLL CALL (5:00 P.M.) - IV. DISCUSSION/ACTION ITEMS

1. Update on the Parker Creek Trail.

City Manager Naffah explained that the Parker Creek Trail was reopened the Friday before Memorial Day. A large log was removed and the base of the trail was made more gradual and less dangerous.

West inquired about future maintenance.

Provolt asked if signage had been updated for Old Home Beach.

2. Update on the repair of the base of the Axel Lindgren Trail.

Naffah informed the Committee that the ALMT remains closed. The six-month closure expires in November. Using a Seventh Generation grant the Tsurai Ancestral Society commissioned GHD to create a report. That report will not be available to the City until after it has been presented to the TAS board.

Lindgren noted that the GHD report is a comprehensive redesign plan and includes restructuring the base of the trail. She said the plan is to present the report to the Tsurai Management Team at the November meeting.

3. <u>Update on the Coastal Commission discussion regarding the Van Wycke Trail.</u> Naffah reported that the Coastal Commission voted not to accept the appeal and gave the City six months to pursue steps toward opening the trail. He said this would require meetings with the Yurok Tribe, Tsurai Ancestral Society, and the Coastal Commission.

Provolt asked if an erosion study had occurred. Naffah said he would talk to the City Engineer to find out when the last geological report took place.

4. <u>Update on Edwards Street striping and crossing zones next year and how it will effect</u> the trails to the harbor, beach and State Park.

Naffah provided an overview of grant-funded crosswalks and striping at Hector Street and at Galindo Street. He said there is also potential for sidewalks.

5. Bench PowerPoint.

West shared the Trails Bench PowerPoint presentation. He also provided a brief overview of the bench policy.

Provolt suggested creating a unique coastal bench style. Hopkins recommended thicker boards or second growth redwood. Mathewson asked about the budget for bench maintenance.

6. <u>Update on trails guideposts.</u> West provided photos of various guideposts.

Lindgren recommended metal posts that require less ground disturbance. She asked that post information be sent to the Tsurai Management Team.

West will meet with State Park representatives in November. He stressed consistency with signage.

There was a discussion about the State Park sign across from the Cal Poly Marine Lab. Hopkins suggested incorporating native names for trails and locations.

7. <u>Discussion about plans and specifications for trails and signage designs. This could include maintenance and assessment of trail conditions.</u> West provided photos of various trail signs and asked for ideas.

Provolt would like to standardize the rock foundations on the benches.

West said that he will also talk with State Parks regarding trail maintenance.

Eli shared that a bench on Edwards is currently being restored. He asked about moving it slightly to the east to provide a view.

8. In-Person meetings.

The Committee discussed AB2449 requiring in-person meetings.

IV. DISCUSSION/ACTION ITEMS

1. Purpose of the meeting.

Council Member West shared a list of goals and a timeline for discussion. The list included maintenance, benches, trail markers and posts, maps, vegetation removal, and partnerships with the State Park, the Yurok Tribe, the Tsurai Ancestral Society, the Trinidad Rancheria, and the Trinidad Coastal Land Trust.

2. City Manager Update.

City Manager Naffah provided brief updates on some of the trails. The City will meet with the Tsurai Management Team on April 3rd to discuss the short-term opening for the Axel Lindgren Memorial Trail. The target date to reopen the trail is July 2024. The City is also looking at improvements for the Van Wycke Trail and along Edwards Street. He said that the Parker Creek Trail is in good shape. The City received a bid of \$11,000 to repair the steps to Trinidad Head. According to Naffah there is at least \$20,000 available for trail repairs.

West added that he met with the State Parks to discuss the interconnectedness of the trails.

3. Trail Committee Goals.

West reiterated the Trails Committee goals and urged all those involved to work together to create a maintenance plan.

4. PowerPoint: Outlining post locations, types of posts and decals.

West provided a detailed PowerPoint tour of the trails system. He discussed locations where the City would like to add posts, areas of concern, types of posts, and trail maps. He stressed the interconnectedness of the trails system.

Edwards Street was mentioned as an alternate route to the Van Wycke Trail. West asked for feedback on changing some trail names to be more historical and culturally sensitive.

West promoted the State Park volunteer work day. It has been postponed to April 27th.

There was a brief discussion about traffic at the base of the boardwalk and future repairs.

The PowerPoint ended with a discussion about various post options, including fiberglass, metal, and Carsonite with informational decals.

Eric Fishman, Trinidad resident, stated that his preference for the galvanized metal posts that could hold a larger sign and for their longevity. He also suggested posting wooden facades to the posts.

Sherri Provolt asked about adding QR codes to the signs.

Cheryl Kelly asked about a long-term plan to replace existing posts and to remove the signs on Wagner Street. She also suggested connecting the trails to the California Coastal Trail and the Great Redwood Trail.

West requested the Committee members return next month with ideas based on these proposals.

Sherri Provolt suggested the TCLT stewardship program help with vegetation removal.

There was a brief discussion about the closures of the Van Wycke Trail and the Axel Lindgren Memorial Trail.

5. Benches: Consider sales of benches for the next meeting.

The City will provide money and maintenance for the Light Keepers bench and the Axel Lindgren bench on the Head.
